1. ACR 93 HOLDEN Encourages all California municipalities to reexamine regulations surrounding mandatory fire suppression ordinances.

2. SB 25 ROTH Provides a city incorporating after January 1, 2004, and on or before January 1, 2012, with property tax in lieu of vehicle license fees (VLF).

3. SB 63 HALL Allow cities and counties to create Seaport Infrastructure Financing Districts (SIFDs), and allows SIFDs to finance port or harbor infrastructure, under specified conditions.

4. SB 239 HERTZBERG Requires a public agency to receive approval from a local agency formation commission (LAFCO) to provide new or extended fire protections services outside its service area, pursuant to a fire protection contract.

5. SB 272 HERTZBERG Requires local agencies, by July 1, 2016, to create a catalog of their enterprise systems, make the catalog publicly available, and post the catalog on their Internet Web sites.

6. SB 330 MENDOZA * Expands the definition of what constitutes a remote interest for purposes of California law governing public officials' conflicts of interest in contracting.

| 7. | SB 399 | HALL | Allows the City of Los Angeles to renew a franchise or permit on, or lease of, specified tidelands and submerged lands, for unspecified periods of time. |
| 8. | SB 441 | LENO | Allows the successor agency to the Redevelopment Agency of the City and County of San Francisco to issue bonds or incur other indebtedness to finance the affordable housing requirements of several designated projects. |
| 9. | SB 485 | HERNÁNDEZ | Authorizes the Los Angeles County Sanitation Districts to acquire, construct, operate, maintain, and furnish facilities to divert, manage, and treat stormwater and dry weather runoff. |
| 10. | SB 493 | CANNELLA | Allows a city with less than 100,000 people to adopt an ordinance requiring the city council to be elected by district or by district with an elective mayor, without being required to submit the ordinance to the voters for approval. |
| 11. | SB 602 | MONNING | Authorizes the California Earthquake Authority to enter into voluntary contractual assessments with property owners to finance the instillation of seismic strengthening improvements. |
| 12. | SB 626 | McGUIRE | Authorizes the Sonoma-Marín Area Rail Transit District's board of directors to establish the position of chief of police and to contract for additional law enforcement services. |
| 13. | SB 741 | HILL | Prohibits a local agency from acquiring or using cellular communications interception technology, unless approved by its legislative body, and requires that local agency to implement a usage and privacy policy for the use of cellular communications interception technology. |
| 14. | SB 762 | WOLK | Allows counties to award construction contracts valued above \$1 million on the basis of best value, until January 1, 2020. |
