ADOPTION OF COMMITTEE RULES

A G E N D A

1. AB 73 CHIU Allows a city or county to create a housing sustainability district to complete upfront zoning and environmental review in order to receive incentive payments for development projects that are consistent with district's ordinance.
2. AB 332 BOCANEGRA Expands a local authority's ability to temporarily close a highway due to serious and continual criminal activity by allowing temporary closure of a through highway or arterial street, and allowing temporary closure due to a serious and continual public nuisance, including, but not limited to, illegal dumping.
3. AB 428 RIDLEY-THOMAS Eliminates a January 1, 2018, sunset date in existing law that allows county health authorities to establish a quorum pursuant to the Ralph M. Brown Act when meeting via teleconference if at least 50% of the board members constituting the quorum are physically present within the boundaries of the authority's jurisdiction and other conditions are met, thereby extending this provision indefinitely.
4. AB 467 MULLIN Authorizes a local transportation authority to instruct county elections officials to replace the adopted county transportation expenditure plan printed in the sample ballot and voter information handbook with a notification that directs voters to view the expenditure plan on the transportation authority's Internet Web site.

5. AB 546 CHIU Requires cities and counties to accept electronic submissions of permit applications for advanced energy storage installations, and requires the creation of a California Energy Storage Permitting Guidebook.
6. AB 549 QUIRK Requires counties and cities to notify their respective fire agencies when they approve a permit for an electrified security fence.
7. AB 733 BERMAN Adds climate change projects to the list of projects that may be financed by an Enhanced Infrastructure Financing District (EIFD).
8. AB 804 C. GARCIA Allows the State Controller to audit any local agency for purposes of determining whether the agency's internal controls are adequate to detect and prevent financial errors and fraud.
9. AB 852 GRAYSON Requires cities and counties to include additional information in the annual general plan report.
10. AB 873 LACKEY Prohibits a reduction in the City of Palmdale's property tax equity allocation as a result of the dissolution of a maintenance district.
11. AB 1189 E. GARCIA Increases the maximum transactions and use tax rate, from 0.5% to 1%, Riverside County Transportation Commission may impose, subject to voter approval.
12. AB 1226 McCARTY * Authorizes the City of West Sacramento and the County of Yolo to replace an appointed member to the Sacramento-Yolo Port District Commission prior to the end of their four-year term of office, as specified.
13. AB 1505 BLOOM Authorizes the legislative body of a city or county to establish inclusionary housing requirements as a condition of the development of residential rental units.

14. AB 1625 RUBIO

Prohibits a local authority, by ordinance or resolution, from prohibiting or restricting the parking of vehicles in a parking space that is regulated by an inoperable parking meter or inoperable parking payment center.
